3) Boat berths and trailer storage is not included in the membership fee; please select the number of boat berths and any additional trailer storage spaces you require (there is no charge if a trailer is kept on a berth with the craft). Berths must be kept tidy and all Craft and Trailers must display "membership sticker" in a visible place.

4) A joining fee of £37.00 is payable by new craft owning members and existing members who fail to renew membership before 1st May

5) To reduce the burden of abandoned boats a storage/ disposal fee of £100 per quarter is payable on boats and other items left at the lake after a membership is considered lapsed (1st June). This may be waived on compassionate grounds.

6) New members joining after September 1st will pay £37 joining fee plus the subscription reduced pro rata

7) Cadet members are those under the age of 18 years or in full time education.

8) Family membership includes member, partner and any children under 18.

9) When allocated a Race Duty (Race Officer or Assistant or Safety Craft Crew) it is your responsibility to attend the duty or appoint a willing deputy in your place

#### INSURANCE COVER:

All craft using Shotwick Lake must be insured for a minimum of £2,000,000 against third party risks and claims. If you are a craft owner, please acknowledge overleaf that you are adequately covered for insurance purposes in accordance with byelaw.

#### SAFETY FACILITIES:

Members, and in particular parents of junior members, are warned that the club is only able to provide safety boat cover during organised club activities, these include Club Racing, Training Courses and Specified Events. Members are reminded that at all other times it is forbidden for one craft to be using the lake without at least one other craft being sailed or available for immediate launch by an adult member.

#### ALLOCATION OF BERTH FOR CRAFT

Existing members should use the same berth that they were allocated for the previous season unless instructed otherwise.
